From time to time we have clients who are traveling single but would like to save the single supplement (100% hotel fare and related costs). We do offer a program that may match you up with another single (of the same sex). It is important to find out a few details about both of the clients that would like to participate in our 'Single Share Option'. We therefore have a few questions for you to complete as shown below. We will offer, with no guarantees, to find another person who is looking for a share as well. Should another person materialize, it is important that both clients have an opportunity to meet each other to assess if they would be compatible. We offer a suggestion that the two clients meet for lunch. Expedia Cruise Ship Centers will cover the cost of this lunch for those involved. The escorts involved in the tour usually attend this lunch meeting, however if time, location etc. does not permit this to be possible then the clients would agree to meet each other on their own. Expedia CruiseShipCenters would arrange the lunch reservations that would be a suitable time and location for both clients.

TERMS & CONDITIONS

It is important to emphasize that this *single share option* is for monetary reasons only. There will be no obligation by either of clients to suggest that they participate together in any or all social events. Each client is to go about enjoying the cruise tour on their own. It is agreed and understood that either client is not to pursue this sharing for the purpose of expanding their socializing with the sharing client. From time to time clients do develop a 'casual holiday relationship' and may agree to enjoy some part of the tour together. Should this arrangement materialize then it is at the discretion of both clients.

Should you wish to take advantage of this great savings you will be required to sign a Single Share Option Waiver Form agreeing to specific terms and conditions. Once the cruise tour begins you will not be permitted to change your cabin mate or move to a separate cabin without subsequent single supplement charges to both parties and this would be strictly based on availability of the ships cabins and hotel rooms. We require both clients to reveal any information that would enable each other to make a fair evaluation as to whether to share or not. Expedia CruiseShipCenters cannot be held liable for any information that is not provided that is later discovered to make the clients incompatible. Should clients agree to share and make deposits and a new condition develops with one of the client sharing, Expedia CruiseShipCenters and the other sharing client must be informed immediately. All parties will meet and discuss the condition with the intention of working out the best possible solution for both parties. *Expedia CruiseShipCenters wishes to make it clear that there is no guarantee at any time that there will be a perfect matching of personalities and it is up to the clients to make the best of any 'single sharing' time together.*

CLIENT CANCELLATIONS: Should one client sharing cancel, the other client has the option of canceling. Should they wish not to cancel and continue to travel as a single, they will be responsible for paying the single supplement cost. They would then have to apply for a refund through a claim with the insurance company providing the claim qualifies for payment.
